16 April 2027	NATIONAL OFFER DATE - Notification of 1 st round offers despatched to parents from LA. Online applicants also able to view the outcome online.
23 April 2027 (WC)	Deadline for receipt of 2 nd round applications.
7 May 2027 (WC)	Late applications (received after 16 January but before 23 April) considered from this date. Applications received before allocation procedure begins will be treated as on-time applications
30 April 2027 – 8 May 2027 (BCC)	Late applications, on-time applicants still seeking a place at their preferred schools and places not accepted to be exchanged between Local Authorities to enable a second round of allocations.
30 April 2027 (BCC/WC/SBC)	Last date for 1 st round offers to be accepted by parents. (If an offer has not been accepted by this date it will be assumed the place is not wanted and will be offered to another applicant.)
8 May 2027 (BCC)	The Local Authority informs schools of 1 st round offers accepted.
13 May 2027 (WC)	EAT to return ranked list of 2 nd round applications to the LA.
14 May 2027 (WC) 5 June 2027 (BCC) TBC (SBC/WBC)	Appeal deadline.
21 May 2027 (WC)	Notification of 2 nd round offers despatched to parents from LA.
7 June 2027 (WC)	Last date for 2 nd round offers to be accepted by parents (If an offer has not been accepted by this date it will be assumed the place is not wanted and will be offered to another applicant.)
June/July 2027 (BCC)	Appeals heard.
July 2027	LA to send final list to EAT of those students expected to join the academy at the beginning of the 2027/28 school year.
