| 1 March 2027 | NATIONAL OFFER DATE - Notification of 1 st round offers despatched to parents from LA. Online applicants also able to view the outcome online. |
| 8 March 2027 (WC) | Deadline for receipt by LA of 2 nd round/late applications (received after 31 October). |
| 15 March 2027 (WC) 15 March 2027 (BCC/RBC/WBC/WC) | Last date for 1 st round offers to be accepted by parents. (If an offer has not been accepted by this date it will be assumed the place is not wanted and will be offered to another applicant.) |
| 15 March – 26 March 2027 (BCC) | Late applications, on-time applicants still seeking a place at their preferred schools and places not accepted to be exchanged between Local Authorities to enable a second round of allocations. |
| 18 March 2027 (RBC) | Late applications for over-subscribed schools added to the waiting lists/change of preferences processed. |
| 18 March 2027 (WC) | Details of second round applications received after deadline and before 8 March to be sent to Academies, Foundation and LA schools. |
| 25 March 2027 (WC) | EAT to return ranked list of 2 nd round applications. |
| 31 March 2027 (WBC/WC) 23 April 2027 (BCC) TBC (RBC) | Appeal deadline. |
| 22 April 2027 (BCC) | The Local Authority informs schools of 1 st round offers accepted. |
| 23 April 2027 (WC) | LA to confirm 2 nd round offers being made. Notification of 2 nd round offers despatched to parents from LA. |
| 23 April 2027 (WC) | 3 rd round/late applications (received after 8 March 2027) can be considered from this date (in date order) |
| 7 May 2027 (WC) | Last date for 2 nd round offers to be accepted by parents (If an offer has not been accepted by this date it will be assumed the place is not wanted and will be offered to another applicant.) |
| TBC (RBC/WBC/WC) May/June 2027 (BCC) | Appeals heard. |
| 31 August 2027 (RBC) | Coordination with other LAs ends. |
